The administration undertook to make the following changes on page 665, DU #304 of the Budget Summaries Manual as per Trustee Fleming's suggestions:

By December 2000, in cooperation with the Capital Health Authority, Edmonton Public Schools will approach the Optometrist, Ophthalmologist and Audiologist Associations to determine their interest and willingness to assist in the provision of vision and hearing testing of our Grade 1 students and by March 1, 2001 recommendations from that consultation will be developed and piloted.

By December 2000, the administrations of Capital Health and Edmonton Public Schools in consultation with parents and staff will develop other options with regard to the provision of speech and language services for students and by March 1, 2001 recommendations from that consultation will be developed and a pilot project examined.

The administration will bring forward recommendations with respect to the following trustee initiative put forward by Trustees Bonko, Dean and Hansen (page 664, DU #304): By January 2001, investigate the establishment of district sites were Integrated Occupational Program (I.O.P.) courses will be available.

## 3. Motion Re: Transportation Policy

#### **MOVED BY Trustee Gibeault:**

"That the district's transportation policy be amended to make bus passes available at half the regular rate to elementary students enrolled in a program of choice at their neighbourhood school when that program of choice is no longer offered at that school and transportation is required to another location to continue in that program until the end of grade six. And further, that this policy change take effect for the 2000- 2001 school year."

<u>Trustee Hansen</u> asked how many students in the French Immersion program are in the Weinlos School catchment area as well as how many students in the program do not reside in the catchment area and whether this policy would apply to them.

Trustee Sulyma expressed concern that this would introduce another fee rate.

<u>Trustee Nicholson</u> asked that information be provided regarding any other anomalous situations such as this in the district.

## Rationale:

- Government health care costs are increasing and with higher premiums our costs for staff will increase and consequently these additional costs would take dollars from the classrooms.
- There tends to be a trend of off-loading more publicly insured services to the private domain such as ASEBP where premiums are increasing.
- The decision to ignore research and other evidence regarding public policy that is consistent with good governance will have great implications for health services and have direct and indirect effects on the classrooms.
