## TRUSTEE REQUEST #295, JANUARY 30, 2001, (TRUSTEE GIBEAULT) - PROVIDE A COPY OF THE COMMUNITY ACCESS PROGRAM ACCEPTABLE USE POLICY.

TRUSTEE REQUEST #296, JANUARY 30, 2001, (TRUSTEE BONKO) - PROVIDE INFORMATION REGARDING THE LARGE INCREASE IN THE COST FOR MAIL DELIVERY FOR FIVE DAYS A WEEK IN PARTICULAR. In preparation of the revisions to the budget manual in October 2000 and the board report of January 30, 2001, the delivery rate for 5 days for 2000-01 was incorrectly reported. The rate should have been \$1,600 for 2000-01 and \$1,680 for 2001-02

TRUSTEE REQUEST #297, JANUARY 30, 2001 (TRUSTEE BONKO): PROVIDE INFORMATION REGARDING WHEN THE RECOVERY COSTS FOR THE MUSIC ENRICHMENT PROGRAMS WILL BE AT 50%. ALSO PROVIDE INFORMATION REGARDING THE MUSIC ENRICHMENT FEES RELATIVE TO THE PARTICIPATION RATES IN THE PROGRAMS OVER THE YEARS. HAVE WE SEEN A DECREASE IN THE PARTICIPATION RATE DUE TO THE INCREASING COSTS OF THE MUSIC ENRICHMENT PROGRAMS? The proposed fee increase for Music Enrichment for the 2001-2002 year is based upon a 50% cost recovery. The fee schedule is outlined below. There is an increase for out of district students and for adults. This fee has remained the same for a number of years prior to this increase.

Increased fees have not affected enrollment in the string program which has experienced a growth of approximately 60 students this year.

There has been a slight drop in the choral enrollment each year. This is not so much a result of fee increase as in the availability of many singing opportunities in community choirs throughout the city. Victoria School is presently operating four elementary choirs with a total of about 180 students

TRUSTEE REQUEST FOR INFORMATION #298: (TRUSTEE MELNYCHUK) PROVIDE INFORMATION AS TO WHETHER THE DIRECTION TO THE DISTRICT TO CHARGE AND COLLECT THE GST ON ALL AFTER-HOURS

RENTALS WAS A NEW REQUIREMENT. WHY WOULD WE BE REQUIRED TO COLLECT THE GST ON ALL AFTER-HOURS RENTALS? Edmonton Public Schools charges and collects GST on all invoices for goods and services billed outside the district in compliance with the Federal Excise Tax Law. Fees for after-hours rentals under the Joint Use Agreement were first implemented in September 1998. GST has been charged and collected by the district on all after-hours rentals since the implementation of the fees. The printed fee schedule always notes that the hourly rate is subject to GST so that users are aware that the GST will be added to the quoted rates. (M. Colgan, 429-8537)
