Recommendation #3

The rationale for the recommendation that was discussed at the Annual General Meeting of the Alberta School Boards' Association for Languages Education (ASBALE) on November 21, 2010 is provided as APPENDIX I. Member boards attending the meeting wanted to take the resolution to their individual boards for consideration and discussion before making a decision.

Recommendation #4

As a part of the ASBA's annual budget planning process, Heather Rogers, ASBA Director Finance and Administrative Services, wrote on behalf of the Board of Directors to all Board Chairs requesting input on the 2011/12 budget by identifying strategic priorities or initiatives that warrant expenditure of Association dollars. She requested the Board review the ASBA Strategic Plan priorities (APPENDIX II) to see if there are items missing, no longer required or that we believe should be given greater priority and to respond by January 6, 2011.

The Board's ASBA Issue and Resolutions Committee met to review the ASBA Strategic Plan with consideration for the common issues identified by the Board over the past few months. The Committee recommended supporting the priority initiatives identified by the ASBA and in particular encouraging the ASBA to maintain its focus on providing support for implementation of a renewed system for special needs students as per the Setting the Direction review.

In addition, the Committee recommended the ASBA be asked to address three additional priority issues in the coming budget year related to:

- 1) strengthen supports for and awareness of the importance of the mental, nutritional and physical health of students as a means of improving student achievement;
- 2) work to revise infrastructure funding to more equitably address the infrastructure needs of schools with low enrolment and alleviate the associated school closure pressures;
- 3) strengthen supports for schools in acknowledging and addressing discrimination, harassment, intimidation and bullying based on individual and systemic biases related to race, colour, ancestry, place of origin, religious beliefs, gender, gender identity, physical or mental disability, marital status, family status, source of income, socioeconomic status and sexual orientation.

The Conference Committee reviewed the ASBA Issues and Resolutions Committee's recommendations at their meeting on January 4, 2011 and made minor modification to priority issue 3 and added an additional priority (see page 2 of report) to provide support to boards in the rollout of the new *Education Act*. The Conference Committee granted permission to submit the recommendations to the ASBA for their deadline of January 6, 2011 (APPENDIX III) and this report is being brought to Board for public record and Board confirmation.

APPENDIX I

Motion for consideration - ASBALE - November 21, 2010 Meeting

BE IT RESOLVED that the ASBALE Membership direct the Executive to pursue having ASBALE disbanded in its current structure and form as a Standing Committee under the direction of the ASBA. The Standing Committee would operate under the current governance structure of the ASBA with a commitment to provide effective representation and to focus on providing leadership in the area of second language acquisition for Alberta Students.

Rationale:

Due to its current structure and lack of resources, ASBALE is not able to expand on its mandate to provide quality leadership and support to School Jurisdictions in the area of policy development and advocacy for language learning.

The benefits of students having a second language have been well documented and second language acquisition is encouraged and supported by Alberta Education.

Second language acquisition also includes English as a Second Language. Statistics indicate that the number of students requiring ESL services continues to increase. In some jurisdictions, ESL students represent 20% of the total student population. To demonstrate, Calgary Catholic has 45,000 students of which 9,200 are ESL students.

The growth of the ESL population will continue to tax School Jurisdictions as they endeavor to meet parental demands for other language learning opportunities for English speaking students.

According to the Federal Government's Immigration Plan for Canada, Canada will be admitting 240,000 to 265,000 immigrants annually commencing in 2010. It is projected that Alberta will have the highest growth second only to Ontario. Alberta's growth rate is expected to be 24.4 per thousand over a 5 year period resulting in an increase of 471,900. Alberta is projected to have a population of 4,159,600 by 2014 compared to 3,687,700 as of July 2009.

Based on the above projections and the 50% growth in ESL students in some AB school jurisdictions in the past decade it makes sound and logical sense for the ASBA to support ASBALE as a standing committee. ASBA's mandate is to provide leadership that is focused on continuous improvement of the public education system and to advocate provincially and nationally on public education issues. It would appear that ASBALE would be a natural fit within ASBA's framework and a means to ensure language services are provided to school boards.
