This program has been in existence in Calgary for 10 years and encourages reading through sports-themed books. Schlumberger agreed to provide funding for an Alberta author to write a story directed at grade five students. The most recent book is entitled "Oil Kings Glory" written by Sigmund Brouwer. Approximately 6,500 copies of the book were distributed to grade five students in 154 district schools.

<u>Trustee Fleming</u> reported that, on Saturday, he had attended the Advanced Placement conference at Strathcona School.

<u>Trustee Huff</u> reported that the District's Long Service Reception was held at the Winspear February 19, 2009. The majority of Trustees were in attendance for this event.

<u>Trustee Huff</u> reported that, on February 26, 2009, she attended the GETTCA conference and heard the key note presentation. Trustees Esslinger and Ripley were also in attendance for this address.

<u>Trustee Huff</u> reported that, on February 27, 2009, she attended the MLA luncheon at the ASBA Zone 23 meeting. Trustees Esslinger, Fleming, Gibeault and Ripley were also in attendance.

She noted that there was no representative from the education community on the working group so she has volunteered to join the committee and will keep the Board updated on the committee's work.

<u>Trustee Esslinger</u> reported that she and Trustees Ripley and Shipka attended the Parents as Partners event *1-2-3 Magic – Effective Discipline for Children 2-12* at the Crowne Plaza on February 25, 2009. There were over 450 parents in attendance.
