B. Roll Call: (2:00 p.m.)

The Superintendent advised that all Trustees were present.

C. Communications from the Board Chair

The Board Chair advised that May 17th is *International Day Against Homophobia*. This day belongs to no one individual, rather it's about people hoping for a prejudice-free world that can provide a place at the table for everyone regardless of their sexual orientation. Inspired by all world theme-days, the day set aside to fight homophobia needs to be appropriated by all of those actively involved in civil society: gay and lesbian community organizations, those organizations focusing on other types of sexual diversity, unions, employers, private businesses, governments, public administration, professional associations, and all individuals seeking equality.

<u>The Board Chair</u> congratulated Mr. Jeff Johnson on his appointment as the new Minister of Education.

D. <u>Communications from the Superintendent of Schools</u>

<u>The Superintendent</u> advised the Board of the following actions taken by students and school staff aligned to the District Priority of deepening students, understanding of equity and empathy as key citizenship traits:

- Students and staff hosted special events celebrating "Leaders in a Global Village" at Bannerman School. For one of their projects, students are making baby blankets and donating them to WINGS of Providence a women's shelter.
- Amiskwaciy Academy students built and donated 12 Houses for Hounds to the Second Chance Animal Society. The project was possible through a Lowe's Toolbox for Education grant.

<u>The Superintendent</u> informed the Board that the District will be hosting two groups of visitors from Singapore on May 14 and 15th. The Motion was UNANIMOUSLY CARRIED.

H. Other Committee, Board Representative and Trustee Reports

<u>Trustee Ripley</u>, the Board's representative on the Edmonton Public Schools Foundation Board of Governors, expressed tremendous thanks to all involved with the very successful *Ready to Shine Fashion Show* at Kingsway Garden Mall. There was great fashions and great work by all the students including several "Astounding Announcers" from Coronation School. Through the enthusiasm and support of Kingsway, the Foundation was presented with a cheque for \$22,000. She thanked all of the donors involved in making that huge donation possible.

<u>Trustee Ripley</u> noted the third annual *Ready for Life* breakfast will be held on Thursday, May 24, 2012. She thanked those Trustees who are attending, and those who are not only attending but inviting guests as well.

<u>Trustee Colburn</u>, the Board's representative on the Alberta School Boards Association (ASBA) Board of Directors, advised that the next meeting will be held May 10 and 11, 2012. He advised that the Community Engagement Task Force he is co-chairing met this morning and is nearing completion of its work. The Committee will submit a report to the Board of Directors in September. The report will then be presented to the ASBA membership at the Fall Annual General Meeting.

<u>Trustee Johner</u>, the Board's representative on ASBA Zone 23, reported on the general meeting held on Friday, April 27, 2012. She noted most of the discussion was with respect to the proposed ASBA 2012-2013 budget. Professional development was provided by the Society for Safe and Caring Schools and Communities. She noted that Edmonton Catholic Schools Trustee Marilyn Bergstra was selected for the King's University College Teacher Education Advisory Committee. She noted the next general meeting will be held on Friday,

May 25, 2012 at 1:00 p.m. at the Executive Royal Inn West. The Edwin Parr Awards Banquet will also be held at the site later that evening.

<u>Trustee MacKenzie</u>, the Board's representative on the Public School Boards Council (PSBC), reminded the Board that Edmonton Public Schools will remain a member of the Public School Boards' Association until January 2013. Trustees are welcome to continue to attend Association events such as the June 2-3, 2012 meeting in Red Deer (prior to the Alberta School Boards Association spring general meeting. She advised that Trustee Shipka will attend as the Board's representative as she is not able to attend. She noted there are also PSBC meetings in late August and October.

<u>Trustee Spencer</u>, the Board's representative on the Capital Region Services to Children Linkages Committee, advised that the next meeting will be held on Thursday, May 10, 2012. Trustee Hoffman will be attending this meeting as the Board's representative.

<u>Trustee Ripley</u> noted that Richard Secord School in, her ward, was vandalized early Sunday morning through a window-smashing spree and break in. She has heard from the Principal and Assistant Superintendent that the school was ready for teaching and learning for Monday morning thanks to the prompt response and the dedicated work ethic of the district's spare custodians, maintenance and security staff. She thanked all of those who were involved in responding so quickly.

<u>Trustee Cleary</u> reported that, on May 2, 2012 she attended the *We Day* breakfast sponsored by Craig Keilburger, co-founder of Free the Children. District staff and local leaders from such as organizations as KPMG, and RBC were also in attendance. *We Day* is a movement by youth for local and global change. Edmonton Public Schools is involved in upcoming plans for thirty schools to participate in *We Day* Alberta on October 24th in Calgary. *We Day* is the largest one-day cause, agnostic platform where a student can't buy a ticket – they must earn their way through service. She is looking forward to attending this event in the Fall.

<u>Trustee Cleary</u> advised that, on May 2, 2012, she also attended the Junior Achievement Alberta Business Hall of Fame Gala. She commended the Junior Achievement company program where over 200 local high school students participated in a tradeshow selling their company products. This was a very rewarding experience for all. The students' ability to innovate and create a sustainable business model and product is a tremendous and authentic learning experience.

<u>Trustee Hoffman</u> reported that the Alberta School Councils' Association recognized King Edward Elementary School with a School Council Award of Merit which recognizes effective school council practices that have an identifiable impact on supporting student learning and school improvement at the school level, the district level or the provincial level.

<u>Trustee Hoffman</u> reported that the Alberta Association for Community Living awarded Julia Kiniski School with a National Inclusive Education Award for 2011 for the tremendous work that they have done to support the inclusion of one specific student at their school. The student is fully included in the school. When the Trustees participated in the Community Relations school tours, they observed him walking laps with the support of a walker and educational assistant while his classmates played cricket in the gym. This student was not walking a year and one-half ago.

Trustee Hoffman reported that she attended the National School Boards Association Conference April 20 to 23, 2012 in Boston. She believed some of the professional development available at the conference was outstanding. One such session was *Thinking Differently: Making Student Achievement your Board's Job.* Another involved Sal Khan who spoke about the Khan Academy and open access learning. She also attended a session on superintendent and board relationships. She is looking forward to finding ways for Trustees to incorporate the learning each of them experienced who attended into the Board's work in the coming year.

J. Trustee and Board Requests for Information

<u>Trustee Shipka</u> requested that the following information be provided:

- What are the reasons that students in some designated communities, such as McConachie and Schonsee, have as many as three under-capacity schools closer to the students' residence than their designated schools?
- What would be the impact of changing the designation of those communities to underutilize schools that are closer to where those students live?

<u>Trustee Johner</u> requested that information be provided on on a range of practices around the province on how boards gather feedback and dialogue with their staff.
