Trustee Bonko, Chairman of the Superintendent's Evaluation Committee (Trustees Gibeault and Nicholson were the other members of the committee) provided the following verbal report with respect to the superintendent of schools' evaluation:

The Board of Trustees recently completed its annual review of the Superintendent of Schools . . . and, what a year it has been for Mr. McBeath.

In September 2001, the Board of Trustees chose Angus McBeath as its chief executive officer after considering a long list of capable applicants. Soon after his appointment there was an election of a new board, comprised of five incumbents and four new trustees. Not too many months later he was faced with the challenge of leading the district through a major disruption when our teachers withdrew their services as a result of a labour dispute.

Prior to his appointment to the superintendency, when he was serving as Department Head, School and District Services, Mr. McBeath provided the leadership for a number of very successful initiatives in the district, including the planning and piloting of the Blueprints for Supporting Teaching and Learning. As such, his appointment as superintendent was warmly welcomed by our district staff. It was clear that such a tribute was much deserved as he orchestrated a very smooth transition between his superintendency and that of his predecessor, Dr. Emery Dosdall. There was no down time, no drop in expectations and no break in the district tradition of constant growth and improvement.

The board views Angus McBeath as a champion of public education who focuses district decision-making on supporting the achievement of students or, as he would say it, "achieving superb results from all kids." He views the education of all children as this district's foremost responsibility, and he encourages the growth of teachers and principals as instructional and learning leaders to achieve this end. In doing so, he has illustrated enthusiasm and an unrelenting focus which has served as a role model for all district staff.

Mr. McBeath has worked hard to establish a good working relationship with the entire board, and he clearly respects the role of trustees as the voice of the community. He has

maintained an excellent relationship with the general community and, in particular, with Alberta Learning, other learning institutions and business leaders. He communicates a vision of what Edmonton Public Schools can and should be, and he communicates this in a manner that is clear and direct, regardless of the audience. He demonstrates excellent communication skills, especially when called upon to respond in an extemporaneous manner.

In its evaluation, the board noted that a particular strength of Mr. McBeath is his ability to establish positive relationships with staff, to empower them, and to elevate the role of each and every one so that they are able to feel that they have a strong voice in decision-making, be it at the local or district level.

Through its evaluation of Superintendent McBeath, this board has demonstrated a high level of confidence in him. The board views him as a man with excellent interpersonal skills who acts with integrity, a man who is credible and leads by example, and a man who holds himself accountable for achieving results.

# I. Committee and Board Representative Reports

•Community Relations Activities

<u>Trustee Woodrow</u> advised that she had attended the 25<sup>th</sup> Anniversary at Aldergrove School and presented a plaque on behalf of the board.

### J. Comments from the Public and Staff Group Representatives

Mr. Bruce MacDonald, co-ordinator of Belgravia and McKernan soccer programs and a board member of the Southwest Minor Soccer Association, expressed concern with the availability of space for soccer practice. They have filed an appeal to the Joint Use Committee to have soccer practice changed from a Category D to Category B since soccer practices are for the purpose of training. They are currently in the process of circulating a petition. He requested that a trustee ask the administration to provide his association with a listing of schools that do not allow soccer practices for the purposes of allowing his group to discuss this with the principals of those schools.

# K. Trustee and Board Requests for Information

<u>Trustee Bonko</u> requested that information be provided regarding the cost to schools of supporting the Joint Use Agreement; e.g. staff costs, utilities and supplies and how much money is recovered through rentals.

<u>Trustee Odynski</u> requested that the following information be provided:

- How much money is coming into the district through non-government agencies; e.g. grants, donations, parent group fundraising, individual and corporate donations within a historical context since 1993-94?
- Will that amount of money increase given the current request that has been made of our schools to review their planned expenditures?

<u>Trustee Odynski</u> asked what would be the financial position of our schools and district if we had actually received sufficient funds to cover the costs of the arbitration award.

<u>Trustee Odynski</u> requested that information be provided on how the district plans to monitor the effects of reduced expenditures on classroom conditions, particularly on class sizes.

<u>Trustee Odynski</u> requested that information be provided on class sizes – how many classes we have had of 30 or more students approved from K-12 since 1993-94.

<u>Trustee Fleming</u> requested that information be provided regarding the number of Educational Specialists employed by Edmonton Public Schools (e.g. speech pathologists, educational psychologists, librarians). How does this number compare to 10 years ago?

<u>Trustee Fleming</u> requested that information be provided regarding which schools in our district have specifically decided not to allow indoor soccer practices to occur within their gymnasiums.
