12. <u>Trustee Subcommittee Review of 2000-2001 School and Central Department Results</u>

MOVED BY Trustee Woodrow:

"That the report entitled 'Trustee Subcommittee Review of 2000-2001 School and Central Department Results' be received for information."

<u>Trustee Bonko</u> expressed the following concerns:

- some schools are not receiving support through the ESHIP initiative.
- lack of commonality of programming across the district that exacerbates the problem of transiency in some communities
- some schools are fundraising for essential items

<u>Trustee Woodrow</u> stressed the importance of all schools having early dismissal time. She suggested that the administration look at the requirement that 85% of parents agree to early dismissal time

<u>Trustee Nicholson</u> expressed concern with some schools' reliance on casinos to maintain sufficient funding.

<u>Trustee Hansen</u> noted a concern raised by schools that were unable to access AISI funding and the inequity this caused. There are pockets of severely disadvantaged students in all areas of the city and we need to be aware of this. There was also concern about what will happen when the AISI funding ends.

<u>Trustee Hansen</u> noted with respect to the results review documentation that in most cases the school profile page was the 1998 version -- we need to look at having the profiles updated.

<u>Trustee Hansen</u> noted the issue of special needs funding for parents who refuse to send their child to a designated site but want them to attend their neighbourhood school instead as being a concern—no funding is provided to the local school for opportunity learning needs.

<u>Trustee Dean</u> expressed concern with the number of parents who attended the results review meetings – he would like to see the numbers increase.

<u>Trustee Dean</u> also expressed concern about schools not practising their emergency plans.

<u>Trustee Martin</u> stressed the need to ensure that programs like the City Centre Project or AISI funding work in order to lobby the government.

<u>Trustee Odynski</u> noted that the schools have urged the board to advocate for the resources that staff need to meet the actual needs of students and take an active role in making the public aware of the critical work that teachers do.

The chairman called the question.

The Motion was UNANIMOUSLY CARRIED.

I. Committee and Board Representative Reports Community Relations Activities

<u>Trustee Hansen</u> noted that he had represented the board at Hazeldean School's 50th Anniversary celebration on November 8, 2001. The event was extremely well attended. He presented a plaque on behalf of the board of trustees.

<u>Trustee Woodrow</u> noted that she had attended the opening of the Safer Schools Brighter Future Conference which ran from November 8 to 10, 2001 and was arranged by the Teachers' Book Depository.

<u>Trustee Fleming</u> noted that he had attended the Remembrance Day Ceremony at the Butterdome on Sunday, November 11, 2001. He and the chairman of Edmonton Catholic Schools, Judy Buddle, placed a wreath as did Karen Beaton, president Edmonton Public Teachers, and the president of Edmonton Catholic Teachers.

<u>Trustee Fleming</u> noted that he attended a meeting today of the <u>Edmonton Journal</u> editorial board along with the superintendent, Mr. Van Ginhovan and Mr. Victor Tanti – the purpose of the meeting was to profile the district.

J. Comments from the Public and Staff Group Representatives

Mr. Steve Brodie congratulated Trustee Nicholson on behalf of the parents of the district for having a school named after him. He wished to stress that district parents are overwhelmingly in support of teachers. He also wished to commend Karen Bardy for her efforts with the Blueprints initiative and Elaine Decker for her efforts with the Key Communicators program – he felt those efforts need to be recognized.

K. Trustee and Board Requests for Information

<u>Trustee Bonko</u> requested information with respect to the district's vision of shared space and what guidelines we are proposing for partnerships with business as well as community groups. Are there working examples that could be examined?

<u>Trustee Martin</u> noted that both he and Trustee Bonko had received a copy of the Alberta Government's Future Summit to Explore a Debt-Free Alberta workbook from the MLA from Edmonton Calder. Has Edmonton Public Schools provided input? If not, should input be provided? He noted that there was a December 1st deadline.

<u>Trustee Woodrow</u> referred to the conference recently arranged by the Book Depository and asked for information regarding the number of district and out-of-district registrants. She asked whether the Book Depository substantially increased their sales as a result of this conference.
