She commended the work of Principal Mary Michailides for playing a very strong role in getting this intake centre established.
- 2. Trustee Odynski advised that she had participated in a focus group on June 25th sponsored by the YWCA which was called One Woman-One Vote. The purpose of this meeting was to get input from women in the city holding elected positions. The purpose of One Woman-One Vote Committee is to assist women in becoming active participants in shaping the public agenda by increasing their participation in the election process and by seeking elected office. She will provide a report to the board secretary for trustee information. She also noted that further information could be obtained from YWCA for students involved in student councils or if there are other women interested in this. The YWCA is looking to partner with other organizations interested in this topic. She also noted that she had attended a breakfast meeting that was held prior to the Federal PC Convention that was held in Edmonton that brought women from across the country to examine this same issue.
