1. The board chair noted that, yesterday, was the 90th anniversary of the Battle of Vimy Ridge. By its name, Edmonton Public Schools' L'Académie Vimy Ridge Academy acknowledges the Battle of Vimy Ridge and honours all those Canadians who made such great sacrifices so long ago for Canada and its future. With its emphasis on Canada, L'Académie Vimy Ridge Academy focuses on building strong Canadian citizens who honour their past and desire to build a strong nation for tomorrow.

The anniversary of the Battle of Vimy Ridge reminds us of the men and women of the Edmonton Garrison currently overseas. Our thoughts and prayers are with them and their families.

2. The board chair advised that thirty-seven district teachers have been named finalists for 2007 Excellence in Teaching Awards. The finalists were chosen from 320 eligible nominees by representatives from Alberta's education community. This year, the awards program is recognizing 130 Alberta teachers, celebrating their outstanding creativity and innovation in their classrooms.

These teachers were chosen because of their excellence in a variety of areas – including knowledge of subject matter, effectiveness with students, creative and innovative teaching practices, involvement with parents and collaboration with colleagues.

Being named a finalist is an acknowledgement from the local school community that these teachers are held in high esteem for their valuable and lasting contribution to the lives of their students — and it is testament to the outstanding teachers we have in Edmonton Public Schools.

The Board of Trustees will recognize the district's nominees during a special ceremony on Tuesday, May 1st.
