### The Deferral Motion was DEFEATED.

<u>Trustee Hansen</u> asked that consideration be given for providing transportation at no cost to parents for students currently designated to attend Hazeldean School who live in the Mill Creek designated attendance area. He also offered a friendly amendment to the motion to clarify that the offer is for students residing in the designated attendance areas for the closed schools.

<u>Trustee Gibeault</u> suggested that clarification be given to parents that this is not "free" transportation but rather is subsidized transportation, the cost of which is borne by the district and asked that this be considered a friendly amendment.

<u>The board chair</u> seeing no objections to the friendly amendments called the question on the amended recommendation:

"That the students currently enrolled in the regular program at High Park, Newton, Mount Pleasant, Mill Creek schools and residing in the designated attendance area be provided with transportation at no cost to the parents to the designated receiving school for the duration of their elementary enrolment at that school."
