4. Motion Re Postponing Consideration of School Closures

"That the Edmonton Public School Board postpone any vote on school closures until such time as the Minister of Infrastructure releases the results of his review of the utilization formula and the board has an opportunity to study the impact of this review on provincial funding policies."

<u>The chairman</u> ruled the motion as being out of order because it is in effect a motion to reconsider the board's decisions to embark on the school closure processes for four schools. Action has already been taken on the board's decisions and a motion to postpone the vote on school closure to a time indefinite would in effect nullify the school closure processes for this school year –as the school closure process must be completed in the same school year as it is begun.

Directive for Action: Given that the Alberta School Boards Association believes that the adequacy and consistency of funding for Alberta school infrastructure is insufficient to meet the existing and future needs of school jurisdictions and that government plans to address the matter have faltered, and further that a comprehensive and committed plan is necessary to properly plan for and manage this important public asset, the ASBA request an independent government funded study to establish such a plan.

2. Directive for Action: That the Alberta School Boards Association urge the Minister of Education to initiate a joint project with those Ministries linked under the Alberta Children and Youth Initiative to fund the use of the Early Development Instrument and of community mapping provincewide for the effective and efficient collection of information that will enable timely and equitable decisions to improve early childhood outcomes and student success in school."

The Motion was UNANIMOUSLY CARRIED.
