C. **Communications from the Board Chair**

The Board Chair advised that, on Monday, January 25, 2010, at the former site of Woodcroft School (now the Institute for Innovation in Second Language Education), he had the privilege of taking part in the official opening the Confucius Institute Library. The library is set up to promote Chinese language and culture and contains over 24,000 volumes in print and electronic form. The library provides resources for Chinese language learning, Chinese history, economics, literature, geography and tourism.

The opening was attended via video conference by the Executive Director General of the Hanban Ministry in Beijing and the Minister of Education of Shandong Province.

The Institute, a partnership formed in May 2008 between China and Edmonton Public Schools, is very active in supporting the learning of Chinese language and cultural activities in Edmonton schools. The Institute is also instrumental in linking the Edmonton region with business and cultural interests in China. The CIE also plays a role with the local World Trade Centre and Chamber of Commerce in helping to improve educational and economic connections between Edmonton and China.

Through this partnership, the Board of Trustees continues to nurture a commitment established by the District's first school board over a century ago to ensure youth can successfully offer their gifts and talents with an increasing integrated global community. The Board recognizes that, in the new millennium, employers across all continents are hiring people who have a diverse set of skills and abilities. We are very proud to be a school district that understands this concept, and we're also very proud to have a long history of offering internationally acclaimed instruction in Mandarin and a variety of other languages.

Providing a dynamic environment in which students can learn, thrive and advance their education is a hallmark of the District's success. By working together, an entire generation of students is being prepared to become the confident and capable leaders of tomorrow.

<u>The Board Chair</u> acknowledged Mr. Stuart Wachowicz and Dr. Wei Li who were in the audience. He noted that Mr. Wachowicz, the director of the Confucius Institute in Edmonton and a former director of the curriculum department at Edmonton Public Schools, received the Qilu Friendship Award -- the highest award that can be bestowed by Shandong Province on foreign experts in business and education.

D. <u>Communications from the Superintendent of Schools</u>

<u>The Superintendent</u> advised that, this afternoon, he along with Assistant Superintendent Dr. Donna Barrett, Director Gloria Chalmers, Manager Karen Bardy, as well as two school principals Dean Michailides and Don Blackwell, met with representatives of various Canadian Somali groups of Edmonton.

He was pleased to be able to report to them the progress being made as a District to meet the educational needs of these Canadian students and that the feedback received from the representatives was cautiously positive. They shared their appreciation for our efforts and expressed the desire to continue to work together to ensure even greater success for their children. He thanked District staff members who have had a positive impact in helping these students experience even more success.

<u>Trustee Huff</u> reported that, on January 12, 2010, she and the Board Chair met with Chris Smith from the Muttart Foundation and Ilene Fleming from Success by 6 to discuss ways to further our shared focus on early education and strengthen our existing partnership.

<u>Trustee Huff</u> reported that, on January 20, 2010, the Board was hosted by the ATA Local for an annual dinner. She thanked Edmonton Public Teachers President Ed Butler.

<u>Trustee Huff</u> reported that, on January 21, 2010, she and the Board Chair as well as a number of the Administration met with Carlana Lindeman of the Paul Martin Aboriginal Education Initiative. They heard some very positive news about the projects that Edmonton Public Schools is piloting to support high achieving Aboriginal students.

<u>Trustee Huff</u> reported on a meeting of the Sexual Exploitation working group that she is a member of as an education representative. She noted that March 15-20, 2010 has been selected as Sexual Exploitation Awareness Week. The theme of the week is *Dare to Care*. A Facebook page has been set up to provide information on the activities that have been planned.
