RECOMMENDATION

1. That revised Board Policy GB.BP Authority for Personnel Decisions (Appendix I) be introduced.
2. That revised Board Policy GB.BP Authority for Personnel Decisions be considered for the first time.
3. That revised Board Policy GB.BP Authority for Personnel Decisions be considered for the second time.

Background

The existing policy has been in place since May 2001. The policy has been reviewed by staff in Personnel Staff Relations and Support Services in 2008. The proposed revisions to the policy clarify the language regarding the Board's delegation of authority to the Superintendent of Schools, including the power to sub-delegate to the members of the Administration, the authority to employ, appoint, determine grid placement, suspend, demote, terminate employment, terminate designation, accept resignations and retirements and approve leaves of absences for all district staff.

The Board retains the authority for the designation and confirmation of principals and for the appointment of exempt management other than supervisors and managers.

Rationale

The policy delegates the authority to the Superintendent to sub-delegate decision making authority to those who are most familiar with the circumstance and who are accountable for the decisions.

Thirty-one staff members, one community member and one parent responded to the web survey. There were two comments related to accountability, and two related to the individuals who received the authority for decision making. The balance of the responses indicated satisfaction with the policy as revised.

- A.** Under the board's general delegation of authority to the superintendent of schools, **which includes the power to sub-delegate to members of the administration, and** subject to section B of the policy, the superintendent of schools will establish, approve and review annually, a document which outlines the ~~delegation of~~ authority to employ, appoint, determine grid placement, suspend, demote, terminate employment, terminate designation, accept resignations and retirements and approve leaves of absences for all district staff.
- B.** The board retains the authority for the designation of principals to the district, the confirmation of principals in their designation, and the **designation or** appointment of exempt management other than supervisors and managers.
