- Eighteen responses were received 7 parents, 2 community members, 4 principal/decision unit administrators, and 5 staff members. 42.1% of the respondents required clarification on some new parts of the policy.

### A. PREAMBLE

The Board believes that all schools should provide facilities that promote optimal learning environments that support the teaching and learning process. On this account the Board believes that the factors that impact student achievement from a facilities point of view are: thermal comfort; indoor air quality; lighting and acoustical control.

#### B. GENERAL

Capital projects are new school construction and school modernization projects identified in the District's capital submission, which is approved annually by the Board and submitted for approval by Alberta Education.

## C. CAPITAL PROJECTS

- 1. Alberta Education establishes the budget for all capital projects. All capital projects require Ministerial approval prior to being tendered and Ministerial approval is required before the Board may enter into a construction contract.
- 2. Contract changes that require funding that is additional to the Alberta Education established capital budget or scope changes that significantly alter the work on a project require Ministerial approval.

# D. SELECTION OF ARCHITECT/CONSULTANT

1. Consultants and Architects shall be appointed by Facilities Services in accordance with district purchasing practices as established by Purchasing and Contract Services.

2. The Board shall be informed of the commissioned architect/consultant for each capital project.

# E. CONCEPT DESIGN OF CAPITAL PROJECTS

The Board shall be informed of the concept design for each capital project.

## F. CONSTRUCTION CONTRACTS, BIDDING AND AWARDS

- 1. The Board may carry out a portion of a project using district forces subject to Ministerial approval.
- 2. A construction contract shall be processed and awarded by the District to the contractor who submitted the tender complying with all conditions; subject to Ministerial approval.
- 3. The Board shall be informed of the approved contractor for each capital project.

### G. DEFINITIONS

- 1. <u>Contract Change</u> An approved change to the contract specification or work necessitated by unanticipated site conditions, circumstances or undeveloped design, within the approved contingency amount for the approved contract.
- 2. <u>Scope Change</u> a significant change in the work to be done that materially alters the description of the original approved concept for the capital project.

Capital projects are new school construction and school modernization projects identified in the district's capital submission, and approved which is approved annually by the Board and submitted for approval by Alberta Education Learning.

# C. CAPITAL PROJECTS

- . The board shall confirm the capital budget for all capital projects.
- 2. Regardless of value, change orders that require funding that is additional to the board confirmed budget, or change orders that significantly alter the scope of work on a project, shall be presented to board for approval.
  - 1. Alberta Education establishes the budget for all capital projects. All capital projects require ministerial approval prior to being tendered and Ministerial approval is required before the Board may enter into a construction contract.
  - 2. Contract changes that require funding that is additional to the Alberta Education established capital budget, or scope changes that significantly alter the work on a project require Ministerial approval.

# D. SELECTION OF ARCHITECT/CONSULTANT

- Consultants and Architects shall be appointed by Facilities Services in accordance with district purchasing practices as established by Purchasing and Contract Services.
- Architectural firms, in the City of Edmonton, shall be sent a letter every three years or as required, signed on behalf of the board, requesting updated information on the firm's status and outlining the requirements for an application for commission.
- 2. The Board shall be informed of the commissioned architect/consultant for each capital project.
- E. CONCEPT DESIGN OF CAPITAL PROJECTS

The Board shall be provided informed of the concept design for each capital project.

- F. CONSTRUCTION CONTRACTS, BIDDING AND AWARDS
  - The Board may carry out any a portion or all of a project using district forces of construction management, subject to ministerial approval.
  - A construction contract shall be awarded to the contractor who submitted the lowest acceptable tender, subject to ministerial approval.
    - 2. A construction contract shall be processed and awarded by the District to the contractor who submitted the tender complying with all conditions; subject to ministerial approval.
    - 3. The Board shall be informed of the approved contractor for each capital project.

## **G. DEFINITIONS**

- 1. <u>Contract Change</u> An approved change to the contract specification or work necessitated by unanticipated site conditions, circumstances or undeveloped design, within the approved contingency amount for the approved contract.
- 2. <u>Scope Change</u> a significant change in the work to be done that materially alters the description of the original approved concept for the Capital project.
