## H. <u>Comments from the Public and Staff Group Representatives</u>

<u>Ms Diana Clifford</u>, Lago Lindo Parent Council, presented a 69-name petition. The petition summary and background states: *We, the parents of children within the Community of Lago Lindo, Klarvatten and Schonsee, petition the Edmonton Public School Board to amend its zoning decision for Florence Hallock School. The boundaries for zoning for Florence Hallock should also include the above mentioned community as it is unreasonable to expect children who live across 167 Ave and east of 97 St to attend another school when Florence Hallock is within walking distance.* 

Children from our community should be allowed the opportunity to choose Florence Hallock Jr. High School. The action petitioned for states: We, the undersigned, are concerned citizens who urge our EPSB leaders to act now to rezone the school catchment area for Florence Hallock to include the Community of Lago Lindo, Klarvatten and Schonsee.

Ms Clifford provided a copy of the petition to the Board Secretary.

<u>Mr. Rory Koopmans</u> advised that he is first person in Alberta to obtain 200 high school credits and to be granted two high school diplomas.

### 15. Committee, Board Representative and Trustee Reports

<u>Trustee Esslinger</u> reported that, on May 20, 2010 she and Trustees Fleming, Huff, Rice and Ripley attended the inaugural Edmonton Public Schools Foundation Fundraising Breakfast *Ready for Life*. At that event, over \$100,000 was received towards early learning and early intervention with many more donations prepared to come. She commended Sandra Woitas, Director Edmonton Public Schools Foundation, for organizing the event.

<u>Trustee Esslinger</u> reported that, today, she participated, as the Board's ASBA Board of Directors Representative, in an ASBA video conference *Communications Protocol/Guiding Principles For School Boards Operating Schools Within Another Board's Boundaries.* The draft information will be updated and presented at the ASBA Spring General Meeting business session.

<u>Trustee Colburn</u> reported that, on May 19, 2010, he attended the first ever Traditional Aboriginal Games Day hosted by the Rites of Passage Program at Prince Rupert School. The Rites of Passage Program is a transition program for Aboriginal junior high youth who are at risk of not being successful in their education. The day consisted of three games: Traditional Village Lacrosse, Run and Scream and Southwest Kickball Racing. Students from Lauderdale and Beacon Heights schools attended and were linked with Rites of Passage students who explained the games. The students also participated in making the objects they were going to use in the games.

<u>Trustee Ripley</u> reported that, last week, she attended an event at S. Bruce Smith School on behalf of the Board where The Honourable Rona Ambrose announced before a group of Grade 8 students that Parks Canada, Nature Canada and the Historica-Dominion Institute have generously funded a free Parks Pass to national parks in Canada as well as to Museums and other national historic sites for all grade 8 students across Canada. The Strive Team at S. Bruce Smith School greeted Minister Ambrose with courtesy and enthusiasm.

<u>Trustee Huff</u> reported that, on May 12, 2010, she and a number of Trustees attended the 15-Years of Service Recognition and Reception for District Staff at the Muttart Conservatory. She commended the organizers of the event.

<u>Trustee Huff</u> reported that, on May 20, 2010, she and Assistant Superintendent Donna Barrett attended the memorial ceremony at Winterburn School for the Baxter family. She commended the Principal Dzivinski for organizing the ceremony.

<u>Trustee Huff</u> reported that, on May 20, 2010, she and Trustees Esslinger, Fleming and Gibeault as well as Superintendent Schmidt and Assistant Superintendent Barrett attended the 2010 Junior Achievement Gala. She thanked Mr. Jay Ball for hosting their group and for providing the tickets to attend the event.

<u>Trustee Rice</u> reported that, on May 14, 2010, he and Assistant Superintendent Jenise Bidulock attended the first official formal graduation exercise from Argyll School. Twenty-seven students were present; however over 100 students completed their diploma through the Argyll Centre. It was a very well done ceremony. He noted that some of the students completed their high school diplomas using the Argyll Centre in combination with attending regular school programs, on-line, or were home schooled. He also noted that a number of people who graduated from Argyll Centre do not come from Edmonton but live in other areas of the province.
