- What factors are contributing to the fact that our teaching force does not reflect as much diversity as our student population?
- Are there enough minority students graduating from the University of Alberta and elsewhere from which the district can hire?
- Would there be any merit in offering teacher applicants an opportunity to self identify their minority status on application forms?
- Are principals of schools with high enrolments of minority students encouraged to consider the importance of good role models for all their students when making staffing decisions?

<u>Trustee Fleming</u> requested information as to whether communications and technological support processes have been established with Edmonton Police Services to rapidly deal with internet threats targeted at students.

<u>Trustee Sulyma</u> requested information regarding what the success rate is of our special needs students particularly in programs like behaviour disordered in the transition from grade 9 to 10. Also what is the retention rate in grade 12?

<u>Trustee Williams</u> requested information regarding the rationale for not providing meningitis vaccinations in elementary and junior high schools. Should this be something that our board approaches Capital Health about?
