INFORMATION

This report provides summary information on future enrolment trends in the District, and information on how district schools will be impacted by the construction of nine new schools. The schools will be built within the next three and one half years through the Alberta School Alternative Procurement (ASAP) initiative.


Background

A key principle that drives the distribution of schools and programs in the District is to ensure equitable access to educational opportunities across the jurisdiction. The principle of equitable access is supported in the Board's Policy AE.BP which advocates for choice in individual programs of study. To achieve this aim, it is important to locate schools close to where growing populations of school-aged children reside. In Edmonton, some parts of the city have excess capacity while others are experiencing a shortage of school space. Matching the number of student spaces with the demand is a key challenge for the District.

The *Ten-Year Facilities Plan 2009-2018* identifies that there are approximately 30,000 surplus student spaces within the District. Despite the closure of 14 schools and five programs since 2000, the District remains significantly oversupplied in terms of instructional space. This situation will become more acute in coming years with six new ASAP schools scheduled to open in September 2010, and three additional ASAP schools scheduled to open in September 2012. These schools will serve students in Kindergarten to Grade 9. By 2012, it is estimated that there will be 37,000 surplus spaces within the District.

Enrolment Outlook

The Planning department has prepared an enrolment projection for September 30, 2009 of 79,038 students. This represents a decline of 570 students or one per cent from the current enrolment of 79,608 students as of September 30, 2008. Enrolment is projected to remain stable at approximately 79,100 students through 2012.



The rapid growth in Alberta's economy has moderated during the past eight months due to depressed resource prices. This is reflected in a marked decrease in employment growth in Edmonton and Calgary. The recent downturn in the global economy suggests that employment growth will continue to slow in Alberta. According to Canada Mortgage and Housing Corporation's (CMHC) Housing Outlook Conference, there were 37,000 jobs created in 2007 in Edmonton, 22,000 jobs were created in 2008, and 2009 is expected to see fewer than 10,000 jobs created. This is Alberta's lowest employment growth forecast in the past decade. The expectation is that the downward trend will continue for next year until major projects like the North East Industrial Area begins development in late 2009-2010. It should be noted that these projects, at this point, are most likely not moving forward due to the current global economic crisis.

Alberta's low unemployment rate has recently been a major inducement for inter-provincial migration. In 2008, over 55,000 people moved to Alberta, more people than have moved to any other province in the last ten years. In 2009, it is expected that net migration to Alberta will continue to be strong but should drop to approximately 50,000 people net migration in the next year. Edmonton will gain a greater share of the Province's new citizens next year according to the CMHC Housing Conference.

Kindergarten enrolment has increased moderately in the past two years following several years of decline. Capital Health census data for 2009 indicates a continuation of a trend of fewer preschool-aged children. For example, in 2008 there were approximately 7,116 four year olds compared to 8,367 four year olds in 2007. Looking at one year olds, there was an increase in population from 8,991 in 2007 to 9,915 in 2008. Capital Health estimates a small gain of one year olds in 2009. Kindergarten enrolment is projected to be 5,117 on September 30, 2009. This number should remain relatively stable for the next five years.

The addition of 7,000 student spaces in the District will directly affect the availability of student spaces at existing schools in other sectors. Appendix I identifies the schools that will be affected by the opening of the ASAP schools. The data is based on student enrolment at affected schools as of September 30, 2008, who live in the future attendance area of a new ASAP school. The number of students who are expected to attend the new ASAP school includes regular students, and an estimated proportion of the current alternative program students who may switch to the new community school. The estimate is based on historical information on the choices that students in alternative programs made when a school was opened in their communities, for example, the number of French Immersion students from Twin Brooks who chose to attend George P. Nicholson School.

Impact on Student Transportation

The opening of the ASAP schools will result in a reduction of buses as many students will no longer require busing to a designated receiving school. However, the net result will not be significant as some of these students will still reside more than 2.4 kilometres from their new school and, in that regard, require transportation services. The level of yellow bus service required is also dependent on several factors, which include such things as availability of public transit services, school hours of operation and route design. Additional information will be provided as it becomes available.

Alternative Programs in ASAP 2010 schools

Alternative programs are distributed to accommodate students in geographically accessible areas. The establishment of a new alternative program must not undermine the viability of

existing sites. The District will use the following criteria to establish the programming needs for the new ASAP schools.

Criteria

- Sufficient interest from attendance area students and exhibited demand of at least 100 students in Division I.
- Sufficient overall capacity to meet the demand of all attendance area students.
- Sufficient space to offer two classes per grade for two consecutive years.
- Feasibility of continuing the program based on anticipated long-term enrolment from the attendance areas.

Conclusion

The opening of the ASAP schools will play a dramatic role in the growth of surplus space within the District. In response, the Administration is reviewing space needs in key sectors in the District. The sector reviews will provide clear strategies to consolidate instructional space and redistribute programs in areas that are greatly impacted by the ASAP schools. In addition, information will be gathered through the upcoming passport and registration process to gain an understanding of how many students intend to register at the new schools for September 2010. Detailed information regarding the sector review process will be presented to the Board of Trustees in March 2009.
