That the Offer to Purchase and Interim Agreement for the sale of Bellevue School to Distinctive Employment Counseling Services of Alberta (DECSA), be approved.

* * * * *

On March 1, 2011 the Administration presented information to the Board of Trustees regarding the Offer to Purchase and Interim Agreement for Bellevue School to DECSA. The terms of the agreement are listed within this report.

Background

The Board of Trustees approved the closure of Bellevue School on May 27, 2003 and the building was declared surplus to district need in 2006. DECSA has been a tenant in the building since December 2003. DECSA develops and provides services to assist individuals with employment barriers achieve paid and meaningful employment and assists employers to find engaged and capable employees. They expressed an interest in purchasing the site in 2006 when the Board declared the site surplus to need. Since 2006, the District has been working with the City of Edmonton and DECSA to reach a favourable agreement regarding DECSA's acquisition of the property, while respecting City rights specified in the *Joint Use Agreement (1996)*. The purpose of this report is to obtain approval for the terms of the final Offer to Purchase and Interim Agreement with DECSA. DECSA will continue to lease the building under the current lease agreement until a final sale can be completed.

The community league was contacted by the District on April 25, 2003 to inform the community of the May 27, 2003 public meeting to consider the closure of Bellevue School. The community league president was contacted on December 5, 2003 by telephone to inform the community of the lease tenant. The president indicated he did not believe the community would have any concerns with DECSA's tenancy in the Bellevue School building. A request was made by district staff to inform the community of the tenancy through standard community league communication.

The City of Edmonton contacted the community league executive in October 2006 to discuss the surplus declaration of Bellevue School by the District. On March 9, 2007 the office of the City Manager sent a letter to the community indicating that the surplus declaration was withdrawn. This was a misunderstanding between the City and District relating to the process. The District did not withdraw the surplus declaration but put on hold discussions relating to the potential sale of the building. On December 7, 2009 the City shared with the community league executive that the current tenant was interested in purchasing the building and that the City was negotiating to preserve its right to purchase the site from DECSA.

The Community League President included a note in the February – April 2010 Community Newsletter indicating that DECSA was interested in purchasing the building and that the City would defer, for now, its first right to purchase. A letter was sent to the Community league president on March 4, 2011 to inform the community of the report to be presented at the March 22, 2011 public meeting. A copy of some of the information shared with the community is attached in Appendix I for your reference.

Approvals and Next Steps

Eastglen School is situated on the same land parcel as the Bellevue School building. Administration has initiated a subdivision application with the City of Edmonton to create a separate land parcel for the Bellevue School building. The application is being processed with an anticipated completion date of September 2011. The area being subdivided does not include the playground or playing fields, which are required by Eastglen School and for the broader benefit of Bellevue residents.

The City of Edmonton and DECSA have entered into a separate agreement allowing the City of Edmonton a first right of refusal to purchase the property from DECSA, should DECSA proceed with a sale of the property at some time in the future.

In accordance with the *Disposition of Property Regulation*, the District arranged for two independent appraisals of the land and building. The initial appraisals were completed in 2006 with an update provided in 2008. In 2006 the land and building were appraised at \$820,000, and between \$1,000,000 and \$1,100,000. In 2008 the appraisals were updated to \$1,230,000, and between \$1,000,000 and \$1,370,000. The offered purchase price represents fair value for this land and building given market conditions since 2008.

<u>Terms</u>

The Administration has retained legal counsel from the firm of Parlee McLaws to work with legal counsel for DECSA to draft this agreement. The proposed sale would include the school building and use of a portion of the land for parking.

The business terms of the sale agreement include the following:

- 1. The agreement is conditional upon the approval of the Board of Trustees and the Minister of Education.
- 2. A new land parcel is being created for Bellevue School building to separate it from Eastglen School site.
- 3. The purchase can only be fully executed when the subdivision is completed and the title is created.
- 4. The District is processing the subdivision application.
- 5. The proposed parcel is 0.97 hectares (2.39 acres).
- 6. The purchase price is established as \$1,150,000.
- 7. A credit of \$80,000 will be attributed to the purchase price as compensation for installing new windows.
- 8. The tenant will provide a \$1,000,000 deposit.
- 9. A rent credit will be applied to the purchase price.
- 10. The rent credit will be the purchase price less four per cent interest, which is retained by the District.

The Board of Trustees for Edmonton Public School District No 7 has given Property Management permission to proceed with disposition of the Bellevue School site. The City of Edmonton has been given notice as per the Joint Use Agreement and the City will have 120 days in which to respond to their first right of purchase clause.

Dear Mr. Finley:

As you know, last May the Edimonton Public School Board (EPSB) declared three school sites surplus to their needs, one of which was the Bellevue Elementary School. Since that time, City staff have been working with these communities to determine if the City should enact our first right to purchase.

While we received a lot of great input through the consultations, the EPSB has since withdrawn their surplus school declaration and the site can no longer be purchased by the City of Edmonton.

The City has requested that the EPSB simply lease the land surrounding the Bellevue site to the existing tenant, who may then purchase the building in order to make some necessary improvements. This arrangement will ensure that the existing open space and playground are available to community use.

If the school site is declared surplus in the future, the City will again have a first right to purchase the property and will work with the local community to determine if it continues to be needed.

In closing, I want to thank you for working closely with the City as we deal with the surplus school sites. The input we receive from community leagues and community groups is invaluable to helping us make the right decisions for our City.
