Dear Mr. Smith:

Your e-mail request of May 19, 2004 is acknowledged with respect to your request for an opportunity to appeal:

- 1. The superintendent's decision not to offer Caraway as an alternative program in the 2004 -2005 year; and
- 2. An anticipated recommendation report to the board of trustees that the Caraway program be discontinued.

Accordingly, arrangements have been made for your group's presentation on the first matter on <u>Tuesday</u>, <u>May 25</u>, <u>2004</u> at <u>7:45 p.m.</u> As this is an appeal of the superintendent's decision, the requirement to meet with a member of the administration to discuss the matter has been waived.

With respect to your second request regarding the "report", Mr. McBeath's letter to you of May 10, 2004 advised that: The administration has heard your view that the district does not have a breadth of offerings for families desiring what is now being called a "slow school" approach. The administration will do follow-up work on this during the next academic year. For clarification, any recommendation to discontinue the Caraway program would come to board after the administration had examined what other possible alternatives for a "slow school" approach might be viable and the degree of parental demand for such a program. The Caraway Parents Society would be consulted in the administration's review. We do not expect that there would be a report to board until well into the next academic year, and in any case, should the board uphold your appeal regarding the offering of the program for 2004-2005, no report would be necessary.

To assist you in your appeal of the superintendent's decision not to offer Caraway as an alternative program in the 2004-2005 year, please be advised of the following board procedures:

• You may be assisted by an advocate or representative to make your presentation. We ask that your presentation not exceed 10 minutes in length. You and/or your spokesperson must be prepared to clarify issues and answer questions for the trustees at the meeting.

- Board meetings commence at 6:00 p.m. and are held in McCauley Chambers on the second floor of the Centre for Education at 102 Street and Kingsway. Underground parking is available. Two seats will be reserved for you and your assistant/spokesperson near the centre microphone in McCauley Chambers where you may be seated until called by the chairman. Please note that Ms Gloria Chalmers has agreed to greet you when you arrive and assist you with seating and getting any materials you may have to the trustees.
- A decision regarding your request will be dealt with at the next meeting of the board (Monday, June 14, 2004) unless otherwise agreed to by a majority vote of the trustees present.
- Normally, if a group has written information it wants provided to trustees with respect a request, it is provided the week prior to the board meeting and included in the report to board. I understand, however, from speaking with Ms Strange that your presentation will be prepared over the weekend and therefore you will not have materials for distribution to the trustees available until the meeting. Therefore, can you please bring 11 copies of any materials to be distributed with you to the meeting.
- A copy of the complete board report being sent to trustees with respect to your group's presentation will be provided to you on Friday, May 21, 2004.

Ms Strange has advised that Mr. Bruce Ziff, a Caraway parent, will be making the presentation. Please advise if there is an additional or alternative speaker so that we may ensure that the Chairman knows who to call on when dealing with that item on the agenda.
