## **INFORMATION**

**Background:** This report is provided in response to a commitment in the February 3, 2009 report to board regarding provision of a special education plan. This plan indicates beginning actions for implementation consistent with the responses provided in Phases 1 and 2 of the province's *Setting the Direction for Special Education in Alberta* initiative.

As outlined in the February 3, 2009 report to board, the District recommended shifts in philosophy and practice in keeping with the province's *Setting the Direction for Special Education in Alberta* initiative (Phase 1). Some of these were, but not exclusively:

- Advocating for adequate and continuous funding from the early years through Grade 12
- Focusing on assessment for programming rather than funding
- Requiring a focus on the functional and educational needs of students

A key focus in the jurisdictional response to Phase 1 was to include parents and support staff as part of a team. The District stated goal was, "to achieve a system (for all students) that respects the knowledge of teachers but also embraces and utilizes the knowledge and expertise of parents and other support people in the child's life. We need a flexible system in which there is a desire to work with everyone on a child's team. Supporting the whole child can only benefit success in the classroom."

The District response to Phase 2 reinforced messages from Phase 1 and included input from district staff, parents and stakeholders. It described what actions were currently in place and believed to be important in the areas of; setting expectations for all students, using strengths and abilities to drive programming, and building capacity for school- based staff and learning teams.

**Work Plan:** The Minister's Forum for Phase 3 of *Setting the Direction* takes place in Edmonton on June 8 and 9, 2009. This provides an opportunity for discussion of the new framework as the Alberta government moves towards system re-design. Based on outcomes from the Forum, the District may further refine its plan. The intent is to move forward with

our District plan on priorities for special needs programming and over time to align these with the Minister's initiatives. The plan is provided in Appendix I. Highlights of the plan include:

- Establishing a parent advisory group to provide input to district direction in implementing *Setting the Direction*.
- Create a demonstration pilot to explore a cross-departmental service model and to extend supports into Grade 3.
- Proposal to continue the inclusion pilot.
- Fetal Alcohol Spectrum Disorder (FASD) research intervention project to explore the use of effective strategies to help students with FASD.

**Next Steps:** The District remains committed to serving all students, including students with special education needs, to enable them to achieve their full potential. The District will report on progress and growth related to the plan.
