<u>The chairman</u> noted that there has been a tremendous outpouring of support for the families of the four members of the Princess Patricia's Canadian Light Infantry who were killed in Afghanistan. This has reached close to home for many of our students and families and the board's thoughts and sincere sympathies are with them and with the men and women of the Edmonton Garrison still overseas.

<u>The chairman</u> advised that the board would also like to express its sympathy for the students and families affected by the recent school tragedy in Erfurt, Germany.

The chairman noted that this week is Education Week. This year's theme is "Reaching New Heights". Education is the key to discovering new possibilities and indeed reaching new heights. It builds individual knowledge and skills, encourages innovation and creativity, and contributes to economic growth and strong communities. Teachers use their creativity and experience to produce activities, learning and great ideas, and innovative approaches to learning for students throughout the district. Education Week is a celebration, and provides an opportunity for schools to showcase how they help students reach new heights throughout the year.

The chairman noted that the Government of Alberta plans to establish a commission to conduct a comprehensive review of the education system in our province. In preparation for this review - the Board of Trustees has invited Key Communicators, School Council Chairs and Junior and Senior High School student representatives to participate in a meeting on Wednesday, May 1, 2002 at Amiskwaciy Academy. This meeting will enable the district's stakeholders to share their thoughts on our education system with trustees and one another. Their input will provide valuable information for the review and trustees are looking forward to the opportunity to meet with our partners in public education.

## 6. Issues for the 2002 ASBA Fall General Meeting

#### **MOVED BY Trustee Hansen:**

"That the following items for submission to the ASBA for policy development and consideration at the 2002 Fall General Meeting, be approved:

## 1. That current ASBA policy 6.L.02 which reads:

The Alberta School Boards Association believes that the formulae used to determine capacity and space utilization of schools and educational facilities must be adaptable to take into consideration changing conditions and variable local needs.

#### Be amended to read:

The Alberta School Boards Association believes that the province's formulae used to determine capacity and space utilization of schools and educational facilities must:

- be adaptable to take into consideration changing conditions and variable local needs.
- exempt from capacity those uses of space that are education-related and complement the K-12 education mandate, including:
  - day care and before and after school child care services including both for-profit and not-for-profit groups
  - pre-school education classes and services such as early education, early intervention, early headstart program space needs
  - government-supported program initiatives such as Student Health Initiative Partnerships and the small class size project
  - adult learning classes
- recognize the legitimate role of schools in providing community services in public buildings by exempting from capacity:
  - community service uses
  - public services and space shared with federal, provincial and municipal departments and agencies such as Child and Family Services, Capital Health, Police Services, etc.

2. That the province be asked to make a provision in the School Act, analogous to section 6 of the Municipal Government Act which states 'a municipality has natural person powers, except to the extent that they are limited by this or any other enactment', which would grant school boards natural person powers."

7. Tenders – Michael A. Kostek School Four Classroom Addition

<u>Trustee Bonko</u> requested that a report be prepared for conference committee with respect to the criteria or regulations pertaining to the random selection process in oversubscribed schools.

<u>Trustee Martin</u> referred to recent media reports regarding citizenship studies and polls where 60% of the respondents did not know the names of Canadian Prime Ministers and in another poll fewer than half the respondents could not correctly identify the Canadian Alliance party as being left or right of the NDP. He also noted that a poll statistic indicated that 7 out of 10 people believe politicians are corrupt. He has found that many young people are taking pride in the fact that they are not voting.

<u>Trustee Martin</u> requested that information be provided on how the social studies curriculum, especially at the high school level, addresses the topic of citizenship.
