- Advised that, at the recent Annual General Meeting of the Public School Boards
 Association of Alberta, Trustee Don Fleming was elected to the position of President of
 PSBAA. Trustee Fleming brings a wealth of experience to the position not only as a
 trustee but also as a Past President of the Association. She congratulated him on behalf
 of the board.
- 2. Advised that, this year, the White Ribbon Campaign began November 28th and will run through December 6th. The White Ribbon Campaign is intended to make the public aware that violence against women is unacceptable. The board endorsed this campaign in 1996 and urges schools and staff to recognize this initiative. CUPE Local 474 has provided each trustee with a white ribbon.

- Trustee Esslinger noted concerns in the schools regarding adequacy of funding to provide support for ESL students.
