C. Communications from the Board Chairman

<u>The chairman</u> reported on the media conference held yesterday regarding Amiskwaciy Academy. The Honourable Dr. Lyle Oberg, Minister of Learning, announced that Edmonton Public Schools and the Government of Alberta have joined forces to open Amiskwaciy Academy for September 2000.

Dr. Oberg announced that the province will provide \$12 million dollars in support of Amiskwaciy Academy, -- \$2 million per year for the next six years. The Honourable Mr. Dave Hancock, Minister of Justice, and Mayor Bill Smith also attended and spoke to the importance of the work Amiskwaciy Academy will be doing and commended the board on its leadership in initiating the Academy. The district is committed to improving its success rate with respect to Aboriginal students as well as the significance of Amiskwaicy Academy as part of the district's programs of choice.

Mr. Bernie Makokis, Director Tribal Chiefs Institute, spoke to the Aboriginal peoples' hopes for this school. He stated that the school will focus not only on student achievement but also on transmitting important cultural values to the students. The Board of Trustees is looking forward to opening Amiskwaciy Academy in the fall. Close to 300 students have expressed an interest in approaching their education from an Aboriginal perspective and are expected to attend the high school in September 2000. Amiskwaciy will be housed at a temporary site located at 10312 - 105 Street for the upcoming school year. Negotiations for a permanent site are currently underway.

D. Communications from the Superintendent

<u>Dr. Dosdall</u> advised that on Thursday, June 15, 2000 at the YMCA 2000 Tribute to Women of Distinction Awards gala, Shirley Stiles, Assistant to the Superintendent, was the recipient of the award in the education category. This award is given for significant contribution or outstanding achievement in the field of education for the educational advancement of Edmontonians.

Jennifer Lawley, principal of W.P. Wagner School and Karen Linden, principal of Oliver School, were among the nominees in this category.

Also, at the gala, Liv Lunde, an 18 year old Victoria School student was the first winner of the YWCA's Women of Distinction Youth Award for women 18 and under. This new award is given for significant contribution or outstanding achievement in any accomplishment or volunteer capacity, showing the promise of a continuing, maturing and meaningful contribution in Edmonton.

Kristie Papsdorf, a student at W.P. Wagner School, was also a nominee in this category.

Heather Raymond, currently on leave, was a nominee in the category Social Sciences, Social Services & Advocacy.

Evaluation of the Superintendent of Schools

<u>Trustee Williams</u>, chair of the superintendent of schools evaluation subcommittee, provided a verbal report regarding the evaluation of the superintendent of schools. The highlights of the verbal report included:

- Dr. Dosdall continued to receive a first-class rating in all areas of performance.
- The board expressed confidence in the leadership of the superintendent and conveyed its appreciation for his vision and leadership, which continues to be focused on student achievement, safety, and quality leadership. Dr. Dosdall provided this leadership within the flattest organizational structure in North America operating significantly below the four per cent cap on central administration.
- Dr. Dosdall, once again, visited all schools at least once during the school year to review the results achieved and the goals established.
- The Edmonton community demonstrated confidence in the superintendent's leadership through its expression of high levels of satisfaction in key areas.

- Dr. Dosdall's accomplishments are numerous and varied. Accompanied with the district's continued enrolment growth is the expansion of programs of choice, i.e., third site for the Nellie McClung program, Amiskwaciy Academy, additional Cogito site, L'Académie Vimy Ridge Academy, and Millwoods Christian School.
- The work of Edmonton Public Schools is recognized worldwide. This year visitors to the district included delegations from Sweden, Japan, Hong Kong, Australia, Vietnam, Israel and Texas. Journalists and reporters from across North America have also expressed interest in the superintendent's leadership style and initiatives.
- Dr. Dosdall is acknowledged for his visionary leadership in both the field of education and the community at large. He serves on the board of directors for the United Way, Edmonton Space and Science Centre, the Alberta Centre for International Education, Scientists 2010 and the Advisory Board of Economic Edmonton.
- Dr. Dosdall has been recognized by the University Council for Educational Administration by being awarded the Excellence in Educational Leadership Award.

<u>Trustee Williams</u> noted that the very positive evaluation must be viewed in the context of the board's continued high expectations. The board expects the achievement results to continue to increase. It also expects the superintendent to:

- continue the positive working relationships with Alberta Learning on curriculum matters
- pursue adequate funding for educating Edmonton Public Schools students
- establish positive working relations with Alberta Infrastructure to ensure resources are made available to maintain the district's physical assets

<u>Trustee Williams</u> concluded by saying that Dr. Dosdall continues to provide high quality leadership and service to Edmonton Public Schools and the community. He is relentless in his pursuit of excellence in teaching and in programming to best serve the students of Edmonton Public Schools.
