RECOMMENDATION

- 1. That revised Board Policy JJ.BP Assisting Community Organizations (APPENDIX I) be considered for the first time.
- 2. That revised Board Policy JJ.BP Assisting Community Organizations (APPENDIX I) be considered for the second time.
- 3. That, in accordance with Board Policy CH.BP Policy Development and Review, revised Board Policy JJ.BP Assisting Community Organizations (APPENDIX I) be considered for the third time at this meeting (unanimous approval is required).
- 4. That revised Board Policy JJ.BP Assisting Community Organizations (APPENDIX I) be considered for the third time and approved.

The Planning and Policy Committee has reviewed Board Policy JJ.BP – Assisting Community Organizations and is recommending the policy be revised.

The revised policy provides a rationale for supporting community organizations and identifies the need for materials to be appropriate and of an educational nature. The revised policy also requires principals to consider the safety of students when evaluating fundraising activities outside the school setting.

As part of the policy review, the Administration conducted an online web survey between May 11 and June 8, 2010. A total of 31 people participated in the survey: 14 parents, one community member, one community/professional organization, five principals/DU administrators and 10 staff members.

The majority of participants did not express concerns with the revision:

- Are there aspects of this policy that require clarification? (69.7 per cent said no)
- Are there additional elements that should be considered in this policy? (86.7 per cent said no)
- Are there elements of this policy about which you have concerns? (85.7 per cent said no)

Participants expressing concerns about the revision made several comments, including:

- Asking for clarification on what would be considered a community-sponsored program, as well as controversial, appropriate and religious material.
- Concerns over how the principal's discretion would be exercised.

As part of the District's site-based decision-making model, principals are given the authority and responsibility to make local decisions related to their school. This approach reflects the district belief that those closest to a situation are in the best position to make most of the decisions when addressing the needs and expectations of the school community. District principals have the opportunity to ask for advice and assistance from their Assistant Superintendent for Schools when making such decisions.

Further, the Board encourages schools to participate in activities intended to assist individuals and groups in need.

School group participation in the collection of goods and funds is permitted: the canvassing for funds from individual students and staff on school premises is prohibited.
