Background

The current policy has been in effect in the District since November 1, 2000. It clearly identifies the principal as having direct responsibility for safety and security. The Superintendent of Schools has established administrative regulations for the procedures and preferred practices that direct the administration in the implementation of this policy.

Process

The policy was reviewed by Security Services and informal feedback attained from principals was considered. Personnel from Leadership Services, Communications and Human Resources were involved in the development of regulations to support the policy. Edmonton Fire Rescue Services was consulted regarding the fire safety regulations to ensure that district regulations reflected standards established by the Alberta Fire Code. Feedback was sought from the Facilities Principal Advisory Committee. This committee includes district administrators and central services staff, as well as the director and managing director of Facilities.

The policy under review was available for feedback from the public on the District web survey for four weeks from May 13, 2010 to June 10, 2010. Thirty responses were received with eleven being district staff, nine Principal/DU Administrators, nine parents, one community member and no Community/Professional Organizations. Twenty-five of the respondents (83.3 per cent) felt that there were no aspects of the policy that required clarification. Twenty-four respondents (80 per cent) indicated that no additional elements should be considered in the policy. Twenty-six of the respondents (86.7 per cent) indicated that they had no concerns with any elements of the policy and eight respondents offered written comments. These comments most frequently reiterated the importance of the policy and emphasized the need for monitoring to ensure that drills are conducted as stipulated. Several respondents commented that the policy should include specific reference to the safety of employees who work in central office. It is felt that employee safety is addressed through Occupational Health and Safety regulations and standards.
