### ISSUE

Each decision we make as a Board impacts students directly or indirectly. We do not always have a student perspective easily available when it comes to making Board decisions. It would benefit the Board to have a student perspective at the table on a regular basis to ensure that a student voice is always at the forefront of our decision making.

### RECOMMENDATION

That the elected position of Student Representative be piloted by the Edmonton Public School Board (EPSB) for the 2014-2015 school year. The purpose is threefold: facilitating dialogue between the student body and the Board, increasing student engagement in Board policy and planning functions and educating students about democratic governance.

### BACKGROUND

For approximately 20 years, the Ontario provincial government has had student trustees participate in public board meetings of each school board. This is defined in provincial legislation. The number of student trustees has ranged from one to three for each board. Many students in Ontario feel that this has been a positive addition to ensuring that student perspectives are presented on a regular basis in decision making.

As a result of Ontario student trustee initiatives, they have authored a mental health policy, urged schools to act on cyber bullying, eliminated bottled water in all schools in one school district, assisted policy makers in developing classroom curriculum, made the collection of school fees more transparent and produced a province-wide student survey.

Although British Columbia does not have a statutory basis for student trustees, the Vancouver School Board has recently approved a one-year pilot project which will enable a student trustee to participate in their board meetings. The individual is not entitled to vote on any matter nor is the individual a "member of the Board". However, the individual may attend all regular public meetings of the board, will present a monthly report, and will participate in matters before the board and provide a student perspective. There is a national movement called "Student Voice Initiative". Their mandate is to have greater student voice in education policy making. This would include having a student trustee or representative participating on each school board throughout Canada. Claire Edwards, of Student Voice Alberta, has approached the District to request that the Edmonton Public School Board consider such an initiative.

### **RELATED FACTS**

Although the district policy feedback process is open for students to participate in giving their perspectives, such feedback is rarely received through the online survey process. As a key stakeholder and the primary recipient of public education, students have important perspectives and expertise regarding their educational experiences. It would be beneficial to find a mechanism which can ensure that we hear their perspectives regularly.

### **OPTIONS CONSIDERED**

The following options have been considered as they are deemed the most admissible:

- 1. Have students who are already participating in the Student Advisory Council elect a representative among themselves.
- 2. Have all high school students vote to elect a representative at large from the district.
- 3. Have the Superintendent appoint a student representative.
- 4. Continue with no student representative.

## **CONSIDERATIONS & ANALYSIS**

Over the 2012-2013 school year the Board had a Student Advisory Committee (comprised of high-school students) who met with the Board twice to discuss educational items. The perspectives we gained in these meetings were helpful. In an effort to develop a greater understanding of student views, it would be of benefit to include an elected student representative at public board meetings for a one-year trial period.

Should the District move forward with an elected student trustee/representative, we have the opportunity to produce better policies, engage students in the governance of their schools, increase democratic participation and improve decision making.

### **NEXT STEPS**

Should the motion pass, the Administration will develop regulations to support either Option 1 or Option 2. This can be determined by the Administration in consultation with school staff and students. Over the 2013-2014 school year, staff will work with Student Voice Alberta representative(s) to increase awareness of the 2014-2015 student representative position and upcoming student election(s). As of Fall 2014, a student representative will be welcome to attend and participate in public board meetings in a non-voting capacity similar to that of the Vancouver School Board's pilot project.
